

INFORMATION ABOUT PERSONAL DATA TREATMENT FOR STUDENTS AND PARTECIPANTS IN CLASSES, CONFERENCES AND EVENTS

According to the Italian Legislative Decree "Personal Data Protection Code" (30th June 2003 n. 196), we would like to inform you that:

1. COLLECTION

Personal data concerning yourself (provided by you or acquired from people indicated by you) will be processed according to current laws.

2. PURPOSES

Personal data will be used, according to current laws, for administrative purposes required to enroll in the class/conference/event that you have chosen.

3. MODALITIES

The processing of personal data will be carried out through our information system, involving the use of electronic or traditional devices; the processing devices comply with current laws and have been set up correctly, in order to guarantee security and confidentiality of the information.

4. EXTERNAL COMMUNICATION

If necessary, after your consent, we will transmit your personal data:

- to Regione Lombardia and/or Provincia di Lecco, in order to observe the requirements needed to provide the event, if organized with public finance;
- to the Ministry of Health and to Regione Lombardia, in order to observe the requirements concerning the event, if subject to ECM credits – Continuous Education in Medicine;
- to the Order of Social Workers in Regione Lombardia.

5. CONSENT OF DATA PROVISION AND CONSEQUENCES IN CASE OF REFUSAL

You are free to provide us personal data and the authorization to process them, but please be aware that if you refuse this consent you will not be able to enroll in the event.

6. DISSEMINATION

Your personal data will not be disseminated and might be communicated only to people authorized by you. Personal data will be processed only by employees in charge of the processing and by employees legitimized by law.

7. YOUR RIGHTS

According to section 7 of the Legislative Decree n. 196/2003 "Personal Data Protection Code", you have the right:

- to obtain confirmation as to whether or not your personal data exist and to obtain such data in comprehensible form;
- to be informed of the source of personal data, of the purposes and methods of the processing;
- to obtain updating, correction or integration of the data;
- to obtain removal, anonymization or blocking of data that have been processed unlawfully;
- to object, on legitimate grounds, to the processing of personal data, except for those that must be preserved by law.

The above-mentioned rights can be performed versus the *data controller* or the *data processor* identified by the *data controller*.
